4. Registration attendees

5. Payment terms

The invoice for exhibition space will be sent after stand confirmation, around mid of April, with a 14 days term of payment.

Invoicing is done by CCO GmbH in EURO.

6. Cancellation / reduction of booked space

- 6.1. until 30.04.2020 is free of charge.
- 6.2. after 30.04.2020, the total amount will be retained.

7. If the payment deadline is exceeded, CCO GmbH reserves the right to cancel the reservation and assign the booked stand space to another company.

8. Stand construction regulations

Refrain from professional stand building. All stands have to be constructed in a ways, that they can be built up on Monday, 14.09.2020 until 20.00 o'clock and dismantled on 15.09.2020 until 22.00 o'clock. Please also note construction height restrictions that might apply.

9. Deliveries / Pick ups

Deliveries to the DEKRA Congress Center have to be made solely on Monday, 14.09.2020. Early deliveries will not be accepted. All deliveries must be coordinated beforehand with the DEKRA Congress Center. 10. The KSK Symposium Armament is a closed event. The invitation to the event will only be issued after approval by the area development of the Special Forces command. For reasons of military security, publication of this event of any kind, for example in social media, on websites, emails, advertisements, etc. is prohibited.

11. Cancellation clause

CCO reserves the right to change the conditions of participation in a justified case. Should political or economic circumstances or force majeure prevent, restrict, change the dates and / or times or the character of the symposium, the participants are not entitled to withdrawal and have no claim for compensation. The above conditions apply mutatis mutandis in the event of a regulatory gap. German law applies. Jurisdiction is Munich.
